Payment for **calendar year filers** are due as follows:

<input type="checkbox"/> 1st Quarter – January to March   Due date is <b>April 18, 2017.</b> <i>Because April 15, 2017, falls on a Saturday and District of Columbia Emancipation Day will be observed on Monday April 17, 2017, you have until Tuesday, April 18, 2017, to make this payment.</i>
<input type="checkbox"/> 2nd Quarter – April to June   Due date is <b>June 15, 2017.</b>
<input type="checkbox"/> 3rd Quarter – July to September   Due date is <b>September 15, 2017.</b>
<input type="checkbox"/> 4th Quarter – October to December   Due date is <b>January 16, 2018.</b> <i>Because January 15, 2018, is an observed holiday (Martin Luther King Day), you have until Tuesday January 16, 2018, to make this payment.</i>

Payment for **fiscal year filers** are due as follows:

<input type="checkbox"/> 1st Quarter – 15th day of the <b>fourth</b> month of the current fiscal year.
<input type="checkbox"/> 2nd Quarter – 15th day of the <b>sixth</b> month of the current fiscal year.
<input type="checkbox"/> 3rd Quarter – 15th day of the <b>ninth</b> month of the current fiscal year.
<input type="checkbox"/> 4th Quarter – 15th day of the <b>first</b> month of the next fiscal year.

If any of the due dates fall on a Saturday, Sunday or legal holiday, you may make the required payment for that quarter by midnight on the next business day following that day.

- ✓ Complete and submit this form in its entirety. Do not cut this page in half.
- ✓ Make your check payable to Arizona Department of Revenue.
- ✓ Write the estate's or trust's EIN and tax year on the payment.
- ✓ Include your payment with Form 141AZ ES.
