

**NOTICE OF CLASSIFICATION
OF PARTIALLY COMPLETED OR VACANT IMPROVEMENTS**

REQUIREMENTS FOR CLASSIFICATION: Pursuant to Arizona Revised Statute § 42-12051, this form is to be used to notify the Assessor that a land parcel contains either a partially completed or vacant improvement and that it should be classified according to its intended use (residential, commercial, etc.). An improvement on the land is considered to be partially completed when the foundation of the structure (or structures) to be located on the property is in place. Property that does not have a structure (or structures) and is actively used for commercial purposes shall be classified accordingly.

INSTRUCTIONS:

- List the parcel(s) being requested for reclassification, the current classification, the requested classification, the date of completion for the partially completed or vacant improvement on the land and its intended use.
- Attach additional forms, if necessary, together with other documentation needed to support your request.
- Return completed form to the county assessor. Please see information below.

NOTE: The property classification descriptions are listed on the notice of valuation and in A.R.S. §§ 42-12001 through 42-12009.
