## What is AZTaxes?

AZTaxes.gov is a free web-based system that allows you (the taxpayer) to electronically file your transaction privilege tax (TPT) returns for your business. It also provides enhanced features that allow you to access your accounts to obtain information.

AZTaxes.gov also allows you to grant access to your accounts to other persons, such as employees, payroll providers or your tax preparer.

AZTaxes.gov provides this access on a secure basis from your computer 24 hours a day/7 days a week.



# Where Do I Begin Filing & Paying TPT?

#### **Register An Account:**

- 1. Click on "Enroll to File and Pay Online" under Businesses.
- 2. Read the information listed on the User Account Registration Welcome page and click "Continue".
- 3. Complete the required fields annotated with a red asterisk.
- 4. Read the Terms of Use policy and check the acceptance box and click "Register".
- 5. You will receive two emails from noreply@azdor.gov. The first e-mail will contain your username, and the second will provide a temporary password. If you do not find these emails in your inbox, please check your spam folder. This password expires after 24 hours.

#### Setup Your E-Signature PIN:

- 1. Log into AZTaxes.gov using the username and temporary password provided in the email.
- 2. Change your temporary password to a password of your choice. The password must contain at least one number, one letter, one special character and must be 8 to 16 characters long.
- 3. After logging in using your personal password, you will be asked to answer four security questions. Make sure you remember your answers or write them down as you will not be able to recall them at a later date. Then click on "Submit Answers".
- 4. Create a self-selected E-Signature personal identification number (PIN.) Your PIN is required to electronically sign your applications and/or returns. Your PIN must be 6 to 10 digits.
- 5. Read the Terms of Use policy and check the acceptance box. Then click on "Save E-Signature PIN".
