REFUSAL OR FAILURE TO FILE

Failure to file a completed report ON OR BEFORE April 1, or the extended due date if an extension is granted, will result in a valuation of one hundred five percent of the prior year's full cash value or a value based upon other information available to the Department. IN ADDITION, A PENALTY will be assessed in the amount of the lesser of one-half of one percent of value estimated by the Department or one hundred dollars per day for each day the taxpayer fails to file the report. The number of days late will be calculated from the original due date, April 1, 2023. (ARS 42-14052)

DEFINITIONS ACCORDING TO A.R.S. SECTION 42-14101 (UNLESS NOTED)

1. "Gas" means: (a) Natural gas, including casing head gas, (b) All other hydrocarbons that are not defined as oil by this section, and (c) Helium and other non-hydrocarbon substances of a gaseous nature.

2. "Geothermal Resources" means: (a) All products of geothermal processes embracing indigenous steam, hot water and hot brines. (b) Steam and other gases, hot water and hot brines resulting from water, other fluids or gas artificially introduced into geothermal formations. (c) Heat or other associated energy found in geothermal formations, including any artificial stimulation or induction thereof. (d) Any mineral or minerals, exclusive of fossil fuels and helium gas, which may be present in solution or in association with geothermal steam, water or brines (ARS 27-651).

"Gross Production" means all oil, gas or geothermal resources produced and saved except: (a) Any interest of the United States or of this state or of any other person or entity that is exempt under the laws of the United States or the constitution or laws of this state in any oil, gas or geothermal resource or in the proceeds of oil, gas or geothermal resources.
(b) Oil, gas or geothermal resources that are used in producing operations or for repressuring or recycling purposes to develop and operate the producer's interests in oil, gas or geothermal resource wells in this state.

4. "Gross Yield" means the amount for which the gross production is sold in the immediate vicinity of the well or, if not sold on the property, the field or posted price or representative market price at the well of oil, gas or geothermal resources that are transported from the property.

5. "Oil" means crude petroleum oil and other hydrocarbons regardless of gravity that are produced at the well in liquid form by ordinary production methods and that are not the result of condensation of gas after it leaves the reservoir.

6. "Produced", "Producing" or "Production" means any taking of oil or gas [or geothermal resources] from any land in this state that is under the state's jurisdiction.

7. "Producer" means a person who owns, controls or leases, either as lessor or lessee, or who has any other interest in oil, gas or geothermal resource lands or oil, gas or geothermal resource wells on January 1 of each year if any person produced any oil, gas or geothermal resource in any manner from the lands or wells during the preceding calendar year. Producer includes any person who owns any royalty or other interest in any oil, gas or geothermal resources, or its value, whether produced by that person or by another person on that person's behalf, either by lease, contract or otherwise.
