## **RE-TITLING UNAFFIXED MOBILE HOMES**

The following are guidelines used to re-title mobile homes no longer affixed on registered owner's real property.

- 1. To re-title, the owner must submit to ADOT/MVD:
  - a) Complete an Application for Arizona Certificate of Title & Registration.
  - b) Submit a copy of the Affidavit of Affixture.
  - c) Submit a lien clearance, if applicable.
  - d) Submit a tax clearance on the real property from the Assessor's Office.
  - e) Have the mobile home inspected to verify the vehicle identification number. (See policy TR 140.5, Vehicle Verification Inspection).
  - f) Ownership documents for travel trailers and for mobile homes may occasionally reflect a deviation of the actual VIN on the unit. (See Section C.2 for VIN deviations).
  - g) Submit a notarized bill of sale if the owner indicated on the Affidavit of Affixture has transferred ownership.
  - h) Provide a written statement that the mobile home is no longer affixed to the real property owned by the applicant.
  - i) Pay the required fees.
- 2. Upon receipt of the title application, the title number(s) or MCO/MSO as listed on the Affidavit of Affixture is to be entered on the database record created for the reactivated mobile home.
