Notice Form 140NR, Schedule A(NR)

Arizona has not fully conformed to the federal changes to the Internal Revenue Code made in 2009.

The following are in addition to those adjustments already included in the 2009 Arizona Form 140NR, Schedule A(NR), instructions:

- 1. <u>Itemized Deduction for Sales Tax on the Purchase of a New Motor Vehicle.</u>
 Itemized deductions must be adjusted to exclude the deduction for the sales tax on a motor vehicle if you made the choice on your federal return to deduct state and local income taxes rather than general sales taxes. Make the reduction to itemized deductions on Arizona Schedule A(NR), line 13, "Adjustments to Charitable Contributions" and next to "charitable" write in "sales tax on vehicle".
- 2. <u>Deduction for Cash Contributions for Haiti Earthquake Relief Made After January 11, 2010 and Before March 1, 2010.</u>

Any 2010 contributions for Haiti relief deducted on the 2009 federal income tax return must be added back on the 2009 Arizona income tax return and the contributions will be treated as 2010 contributions for Arizona income tax purposes. Make the reduction to itemized deductions on Arizona Schedule A(NR), line 13, "Adjustments to Charitable Contributions".
