INDIVIDUAL INCOME TAX CREDIT FOR DONATIONS TO PRIVATE SCHOOL TUITION ORGANIZATIONS: REPORTING FOR 2010

EXECUTIVE SUMMARY

- \$43,177,050 in donations to private school tuition organizations were reported to the Arizona Department of Revenue for 2010. This is a decrease of 15.1% over the \$50,880,647 reported for 2009.
- 62,959 donations to private school tuition organizations were reported, a decrease of 14.3% over 2009.
- The Department was aware of 53 school tuition organizations operating in Arizona in 2010, one less than the 54 STOs that participated in 2009. (Two STOs discontinued operations in 2009 and one started operating in 2010.)
- The average donation in 2010 was \$686. This is a decrease from the \$693 average in 2009.
- Scholarships paid by school tuition organizations in 2010 totaled \$47.4 million, a 9.1% decrease over the amount of scholarships paid in 2009.
- The number of scholarships paid in 2010 was 26,453, a 4.1% decrease from the 27,592 scholarships paid in 2009.
- 367 private schools in Arizona received scholarship money from school tuition organizations, 3 less than last year.
- Three school tuition organizations gave scholarships to only one private school.
- Four school tuition organizations gave scholarships to 100 or more private schools.
- The smallest average scholarship paid by a school tuition organization to a school was \$50, paid by the Arizona Scholarship Fund to Parker Apostolic Christian Academy in Parker.
- The largest average scholarship paid by a school tuition organization to a school was \$26,944, paid by Arizona Scholarship Fund to the Ethos School.
- The majority of the scholarships (64%) and the scholarship money (65%) was paid to schools in Maricopa County.

INDIVIDUAL INCOME TAX CREDIT FOR DONATIONS TO PRIVATE SCHOOL TUITION ORGANIZATIONS: REPORTING FOR 2010

Arizona's individual income tax credit for contributions to school tuition organizations, referred to as the private school tax credit, is governed by A.R.S. §43-1089. School tuition organizations (STOs) must report the following information to the Arizona Department of Revenue by February 28:

- 1. The name, address and contact name of the STO.
- 2. The number of contributions received in the previous calendar year.
- 3. The dollar amount of contributions received in the previous calendar year.
- 4. The number of children¹ awarded scholarships or grants during the previous calendar year.
- 5. The dollar amount of scholarships and grants awarded during the previous calendar year.
- 6. The name and address of each qualified school² receiving the scholarships or grant money, along with the number and dollar amount of scholarships or grants provided to each school.

Legislation signed into law in 2010 changed the STO reporting period to a fiscal year beginning July 1 and ending June 30. Calendar year 2010 is the last year for calendar year reporting. All future reports will be for the fiscal year period.

The Arizona Department of Revenue was aware of 53 STOs operating in Arizona in 2010, one less than in 2009. (Two organizations stopped operating: Children's Scholarship Network of Arizona and Montessori Centre School Tuition Organization. One organization started operating in 2010: Arizona Education Scholarship Foundation.) The number and amount of donations are set out in the following table. For calendar year 2010, \$43.2 million has been reported by 53 STOs, a 15.1% decrease over the donations reported for 2009.

Arizona Christian School Tuition Organization is the largest school tuition organization in terms of number and amount of donations received. Arizona Christian School Tuition Organization reported \$8.7 million in donations, 20.2%

¹ The Department of Revenue has determined that "children" as identified in this statute would generally be 18 years or younger.

² Qualifed school is defined in statute as a "nongovernmental primary school or secondary school or a preschool for handicapped students that is located in this state, that does not discriminate on the basis of race, color, handicap, familial status or national origin …" The Department of Revenue has further clarified this by saying that these primary and secondary schools must educate children in a course of study that leads to promotion to the next class or to graduation.

of the total. The Catholic Tuition Organization of the Diocese of Phoenix reported \$7.9 million in donations, 18.2% of the total reported. These two organizations received more than 38% of the total donations. Of the 52 STOs reporting in both 2009 and 2010, 42 saw a decline in donations from 2009. To review the donations reported by each STO, see Appendix I at the end of this report.

STOs reported 26,453 scholarships paid for \$47.4 million in 2010, an average of \$1,791 per scholarship⁷. This is a 4.1% decrease in the number of scholarships reported over calendar year 2009 and a 9.1% decrease in the total scholarship paid. The following table shows the history of scholarships and grants paid out by STOs, based on information reported to the Department of Revenue. The range of average scholarship amounts paid by the individual STOs is from \$245 (Alternative Schools Scholarship Fund) to \$6,821 (Arizona Independent Schools Scholarship Fund). To review the scholarships paid by each STO, see Appendix II at the end of this report.

Of the 54 STOs that paid scholarships in 2010, 19 increased their average scholarship amount from the prior year. Three STOs paid scholarships for the first time, so their average scholarship amounts neither increased nor decreased.

STOs provided scholarships and grants to 367 private schools throughout Arizona. There were 32 private schools that received scholarship money in 2009 year that did not receive any scholarship money in 2010.

Arizona Scholarship Fund provided scholarships and grants to 160 schools, more schools than any other STO. Appendix III, at the end of this report, lists the number of schools to which each STO provided scholarships and how many more or less schools received scholarships from the STO in the prior year. For example, Arizona Adventist Scholarships provided scholarships to 12 schools in 2010, which is three less than last year. That information is aggregated in the following table.

As shown above, three STOs gave scholarships to only one private school. Those three STOs are Arizona Education Scholarship Foundation, Life Development Institute Education Fund and Scholarship for Educational Excellence.

Two private schools, Christ Lutheran School and Northwest Christian School, received scholarship/grant money from eleven different STOs. Two private schools, Scottsdale Christian Academy and Valley Lutheran High School, received scholarship/grant money from ten different STOs. The following table shows the number of STOs contributing scholarship/grant money to the private schools.

In other words, 149 private schools received scholarship/grant money from only one STO. There were 73 private schools that received scholarship/grant money from two STOs.

The *smallest* average scholarship paid by an STO to one private school was \$50 paid by the Arizona Scholarship Fund to Parker Apostolic Christian Academy in

Parker. Six private schools received average scholarships from STOs for more than \$10,000. The *highest* average scholarship paid by an STO to one private school was \$26,944 paid by Arizona Scholarship Fund to Ethos School.

Seven private schools received more than \$1 million total from all STOs. The most scholarship/grant money received by one private school from all STOs was \$1,403,395 for 974 scholarships (\$1,441 average) to Northwest Christian School in Phoenix. Appendix IV lists the 367 private schools that received scholarship/grant money, the number of scholarships, the amount and the average scholarship. This table also shows the percent change in amount of scholarship money received and the percent change in the average scholarship paid if the school also received scholarship money in 2009. Highlighted schools received more scholarship money in total than in 2009 and had a higher average scholarship than in 2009. (The total number of scholarships shown on Appendix IV totals 26,654, 201 more than the number of scholarships shown on the table on page 3. STOs reported that 201 students received scholarships to two schools, meaning they switched schools at some point in the calendar year.)

The following table presents the distribution of average scholarships. For example, the average scholarship received by six private schools was between \$1 and \$250. The average scholarship received by 7 private schools was between \$251 and \$500.

Of the 367 private schools, 62 (16.9%) had increases in both total scholarship money and average scholarship money. In 2009, 84 (22.7%) private schools had increases in both total scholarship money and average scholarship money.

In terms of where the scholarship/grant money went within Arizona, the most money went to schools within the city of Phoenix. About 32% of the

scholarships went to 75 private schools in Phoenix and almost 32% of the money. As would be expected, 64% of all scholarships granted went to schools in Maricopa County and 65% of the money. Appendix V shows the cities within which the scholarship/grant money was received, the average scholarship and the percent change from 2009. It also shows the rank for 2010 and for 2009, which indicates the community with the highest average scholarship (Mayer #1 with an average scholarship of \$4,597) to the lowest average scholarship (Holbrook #69 with an average scholarship of \$197).

CORPORATE INCOME AND INSURANCE PREMIUM TAX CREDITS FOR CONTRIBUTIONS TO SCHOOL TUITION ORGANIZATIONS

REPORTING FOR 2010

The corporate income tax credit and insurance premium tax credit for contributions to school tuition organizations is governed by A.R.S. § 43-1183, A.R.S. § 20-224-06 and Chapter 15 in Title 43. (This report does not cover the corporate income and insurance premium tax credits for scholarships for disabled/displaced students, A.R.S. § 43-1184 and § 20-224.07.) School tuition organizations (STOs) participating in the "original" corporate tax credit program were required to report the following information for calendar year 2010 to the Arizona Department of Revenue by June 30:

- 1. The name, address and contact name for the STO.
- 2. The number of contributions received in the previous calendar year.
- 3. The dollar amount of contributions received in the previous calendar year.
- 4. The number of children awarded scholarships or grants during the previous calendar year.
- 5. The dollar amount of scholarships and grants awarded during the previous calendar year.
- 6. The name and address of each school receiving the scholarships or grant money, along with the number and dollar amount of scholarships or grants provided to each school.
- 7. Verification that an independent review of financial statements according to generally accepted accounting principals (GAAP) was completed by a certified public accountant for the previous calendar year.

Additionally, the Arizona Department of Revenue asked for information regarding the total amount of scholarship/grant money being held for specific students for future year scholarships.

The Arizona Department of Revenue was aware of 53 STOs operating in Arizona in 2010. Eleven of these STOs received donations in the

corporate income and insurance premium tuition tax credit program in 2010.1

DONATIONS BY CALENDAR YEAR

In calendar year 2010, \$11,123,657 was donated by 63 corporations² to 11 STOs. Corporate donations ranged from \$500 to over \$1 million. The range of donations made to an STO are shown below:

Effective in 2009, insurance companies were allowed to participate in this program. Insurance companies do not pay corporate income tax; instead they are allowed an insurance premium tax credit. Eight insurance companies participated in the program in calendar year 2010, donating \$798,833.

SCHOLARSHIPS

Corporate tax and insurance premium tax credit scholarships are subject to strict guidelines, unlike awards of individual income tax credit scholarship money. Recipients of corporate scholarships must meet the following guidelines:

- 1. Family income cannot exceed 185% of the income limit required to qualify a child for reduced price lunches under the national school lunch and child nutrition acts. (Maximum annual income of \$75,467 for a family of four for 2010.)
- 2. The student receiving the scholarship must meet one of the following:
 - a. Attended a governmental primary or secondary school fulltime for at least the first 100 days of the prior fiscal year and then transferred to a qualified private school.
 - b. Enroll in a qualified private school in a kindergarten program.
 - c. Received a scholarship under one of the two previous guidelines and continues to attend a qualified private school in a subsequent year.
- 3. In 2010, a school tuition organization cannot issue a scholarship in an amount that exceeds:
 - a. \$4,600 for students in kindergarten through grade 8

Appendix II, at the end of this report, shows scholarships paid by all STOs for calendar years 2009 and 2010.

As can be seen in the table above, the Catholic Tuition Organization of the Diocese of Phoenix provided scholarships to 1,442 recipients. Two STOs, Jewish Education Tax Credit Organization and Northern Arizona Christian School Scholarship Fund, provided scholarships to only one school. Scholarship money went to 187 schools in 2010, as compared with 169 schools in 2009. Appendix III, at the end of this report, shows all schools receiving scholarships out of the corporate income and insurance premium tax credit donations

CPA REVIEW

STOs that participate in soliciting corporate contributions are subject to a CPA review that is not required with the individual contributions. On the form on which STOs report the statutorily-required information, there is a place for a certified public accountant to sign, indicating that the required review took place.

The CPA review was reported as complete by most STOs. The remaining STOs reported that their CPA review was in progress or pending. Shaded squares indicate no participation in that year.

DONATIONS BY FISCAL YEAR

Donations to STOs to receive the corporate income tax or insurance premium tax credit are limited by statute. Statutory limitations are by fiscal year. For fiscal year 2007, the limitation was \$10 million. This limitation increases 20% per year³.

The following table shows the amount approved in each fiscal year as opposed to the amount received. It also divides the fiscal year donations into the calendar years in which they were received. Of the \$17.28 million limitation for fiscal year 2010, \$8.12 million was approved and almost \$8.10 million was actually donated.

³ House Bill 2288, Chapter 168, was signed into law in the first regular session 2009. This legislation removed the original sunset date of June 30, 2011 and allows the credit limitation to continue to grow by 20% annually. It also extended the credit to the insurance premium tax.

⁴ The entire \$12 million was approved in the fiscal year. Two corporations, donating \$4,000, asked for a refund after the fiscal year ended when it became clear to them that the program does not work for S corporations that pass their tax liability through to the shareholders.

CORPORATE INCOME AND INSURANCE PREMIUM TAX CREDITS FOR CONTRIBUTIONS TO SCHOOL TUITION ORGANIZATIONS FOR SCHOLARSHIPS FOR DISABLED/DISPLACED STUDENTS

REPORTING FOR 2010

The corporate income tax credit and insurance premium tax credit for contributions to school tuition organizations for scholarships for disabled/displaced students, is governed by A.R.S. § 43-1184 and § 20-224.07. School tuition organizations (STOs) participating in the tax credit programs must report the following information to the Arizona Department of Revenue by June 30:

- 1. The name, address and contact name for the STO.
- 2. The number of contributions received in the previous calendar year.
- 3. The dollar amount of contributions received in the previous calendar year.
- 4. The number of children awarded scholarships or grants during the previous calendar year.
- 5. The dollar amount of scholarships and grants awarded during the previous calendar year.
- 6. The name and address of each school receiving the scholarships or grant money, along with the number and dollar amount of scholarships or grants provided to each school.
- 7. Verification that an independent review of financial statements according to generally accepted accounting principles (GAAP) was completed by a certified public accountant for the previous calendar year.

The Arizona Department of Revenue was aware of 53 STOs operating in Arizona in 2010. Five of these STOs received donations in the corporate income and insurance premium tuition tax credit program for disabled/displaced students in 2010.¹

DONATIONS BY CALENDAR YEAR

In calendar year 2010, \$956,880 was donated by 6 corporations² to 5 STOs. The Tuition Organization for Private Schools received the most donations for a total of \$438,880. Three STOs received only one donation. The following table shows the number and amount of donations received by each STO in 2010. Appendix I, at the end of this report, shows donations to all STOs for calendar years 2009 and 2010.

As with the original corporate credit for contributions to school tuition organizations, insurance companies are also allowed to participate in this program. Insurance companies do not pay corporate income tax; instead they are allowed an insurance premium tax credit. In calendar year 2010, four insurance companies participated in the program donating \$734,000.

SCHOLARSHIPS

Recipients of disabled/displaced scholarships must meet the following guidelines:

- 1. The student must have an Arizona individualized education plan (IEP), 504 plan or was placed in the Arizona foster care system.
- 2. The student receiving the scholarship must meet the following:
 - a. Received a grant or scholarship from the former Arizona Department of Education program in the 2008/09 academic year; or
 - b. Attended a governmental primary or secondary school full-time for at least the first 100 days of the prior fiscal year and then transferred to a qualified private school; or
 - c. Received a scholarship under one of the two previous guidelines and continues to attend a qualified private school in a subsequent year.
- 3. The amount of the scholarship shall not exceed the lesser of the cost of tuition or 90% of the amount of state aid that would have been computed for the student to attend public school.³

³ For the 2009/2010 academic year, students that received a scholarship/grant in 2008/2009 under the previous program administered by the Arizona Department of Education may receive a scholarship equal to the scholarship/grant amount received in 2008/2009 though limited to the cost of tuition.

The legislation creating the disabled/displaced credit became effective August 26, 2009. Given the short time available to receive donations during the 2009/2010 academic year, the legislation allowed STOs to fund disabled/displaced scholarships from donations received through the original corporate STO credit (A.R.S. § 43-1183) for the 2009/2010 academic year.

Students who received scholarships or grants in the 2008/2009 academic year from the disabled and displaced scholarship/grant programs administered by the Arizona Department of Education could receive a scholarship funded by donations made to the original corporate credit program. In doing so, the income restrictions and scholarship amount restrictions set out under the original corporate STO credit are not applicable to the qualified students. This exception exists only for the 2009/2010 academic year. Two STOs, the Arizona Corporate Scholarship Fund and the School Tuition Association of Yuma, used original corporate money to award all of their disabled/displaced scholarships in CY2010 for the 2009/2010 academic year.

Six STOs reported disabled/displaced student scholarships awarded in 2010. These STOs reported 166 scholarships totaling \$715,424. Also shown below is the number of schools receiving scholarships from each STO.

As can be seen in the table above, the Institute for Better Education provided 71 scholarships. Two STOs, New Valley Education Partners and the School Tuition Association of Yuma, provided scholarships to only one school. School Choice Arizona had corporate money available but did not fund any scholarships in 2010.

Scholarship money went to 68 schools in calendar year 2010 as compared with 37 schools in 2009. Appendix III, at the end of this report, shows all schools receiving scholarships out of the disabled/displaced corporate income and insurance premium tax credit donations in calendar year 2010. Because the scholarships awarded in a calendar year may cover two different academic years, Appendix IV lists the schools that received scholarships in calendar year 2010 and allocates the scholarships to the appropriate academic year (2009/2010 or 2010/2011).

QUALIFIED STUDENTS

The Arizona Department of Revenue maintains the list of qualified students for the disabled/displaced scholarship program. When this program was created, statute provided that students who had received a tuition grant or educational scholarship from the Arizona Department of Education during the 2008/2009 academic year were grandfathered onto the list of eligible students for the disabled/displaced scholarship program beginning with the 2009/2010 academic year. The Arizona Department of Education identified 477 students under the old programs that were grandfathered onto the qualified student list in the first year.

For the current program, new students must first apply for eligibility with the Department of Revenue to determine that they meet the qualifications set in statute in order to receive a disabled/displaced scholarship from an STO. In calendar year 2010, 64 applications for eligibility were received. Of those applications, 47 were determined eligible to receive a disabled/displaced scholarship.

CPA REVIEW

STOs that participate in soliciting corporate contributions are subject to a CPA review. On the form on which STOs report the statutorily-required information, there is a place for a certified public accountant to sign indicating that the required review took place.

The CPA review was reported as complete by the STOs that received donations for the disabled/displaced scholarship program. Shaded squares indicate no participation in that year.

DONATIONS BY FISCAL YEAR

Donations to STOs to receive the disabled/displaced corporate income tax or insurance premium tax credit are limited by statute. The statutory limitation for the disabled/displaced tax credit is set at \$5 million per fiscal year.

The following table shows the amount approved in each fiscal year as opposed to the amount received. It also divides the fiscal year donations into the calendar years in which they were received. Of the \$5 million limitation for fiscal year 2011, \$1.079 million was approved and \$1.029 million was actually donated.
