Purpose of Arizona USE-V Tax Form

Individuals are required to pay use tax on out-of-state purchases for your personal use and paid no tax, or paid another State's sales tax, or excise tax, at a rate that is less than the Arizona use tax rate.

For more information about Use Tax please refer to our Use Tax Publication 610A, available at www.azdor.gov.

(1) Name and Address

Enter FIRST and LAST name, mailing address including city, state, and zip code, and daytime phone number.

(2) Taxpayer Identification Number

Enter your Social Security Number (SSN).

(3) STATE (AZ)/COUNTY Tax Transaction Detail

- A. Business Code (no entry required)
- B. Region Code: Enter the County in which it was received or used. You can find this information on the Arizona Transaction Privilege and Other Tax Rate Tables on azdor.gov.
- C. Taxable Purchase Amount: Enter purchase price.
- D. Tax Rate (no entry required)
- E. **State Tax Amount**: Multiply amount in column C by tax rate in column D.

(4) CITY Tax Transaction Detail

If the single item purchase amount is \$1,000 or less, OR if City tax is **not** applicable, skip this section.

- A. Business Code
- B. **City Code**: Enter the City in which the tangible personal property is being used, stored or consumed. You can find this information on the Arizona Transaction Privilege and Other Tax Rate Tables on azdor.gov.
- C. Taxable Purchase Amount: Enter purchase price.
- D. **Tax Rate**: Use the AZ Tax Rate lookup tool at www.AZTaxes.gov/Home/Address. You can also find this information on the Arizona Transaction Privilege and Other Tax Rate Tables on azdor.gov.
- E. City Tax Amount: Multiply amount in column C by tax rate in column D.

(5) Calculate Total Use Tax Due

- A. Enter STATE TAX AMOUNT.
- B. Enter CITY TAX AMOUNT.
- C. Enter TOTAL USE TAX DUE for lines A + B.

(6) Sign Form and Prepare Payment

Review Before Mailing

To avoid processing delays and costly errors, take a few moments to make sure you have entered all of the required information and verify that it is accurate.

Taxpayer Signature

Sign and date the form.

Make your check or money order payable to Arizona Department of Revenue.

Write your SSN and "Use Tax" on your payment.
