#### **Call to Order**

#### Approval of Minutes

## Second Preliminary Personal Income Estimates and Population Estimates for FY2023 and FY2024

After discussion by commission members, a motion was made by Elliot Pollack to accept the estimated personal income numbers of \$467.6 billion for FY 2024 and \$495.2 billion for FY 2025. Motion was seconded by Neeraj Deshpande. Motion carried. Elliot Pollack made a motion to accept the population estimates of 7.564 million for FY 2024 and 7.660 million for FY 2025. Motion was seconded by Neeraj Deshpande. Motion carried.
